- MLM are welcome, but for sales only. Recruitment is not allowed.
- There is no fee, but a donation to the FRWC is appreciated!

# 80's in the Hole Car and Music Festival

## Terms and Conditions

1. **Set Up / Break Down:** All exhibitors may begin to set up at 3:00 and must be ready for attendees by 6:00 PM. Vendors are free to drive their car onto the site to drop off supplies, but must move vehicles to the parking area prior to the start of the event. Vehicles can return for breakdown after the crowd dissipates. Vendors may break down sooner (no sooner than 10:00 PM) but must wait to load vehicles until after the crowd dissipates.
2. **Vendor spaces** will be distributed on a first come first serve basis. If you have special space needs, please include your request with your application and we will attempt to accommodate you.
3. **Staffing:** Vendor tables/trucks must be staffed at all times and intact until 11:00 PM. Flint River Watershed Coalition and Kettering University are not responsible for merchandise or display materials.
4. **Exhibitor Items:** Flint River Watershed Coalition and Kettering University reserve the right to have items removed that are considered not appropriate. No open flames. Selling of profanity, tobacco, or suggestive materials are not permitted.
5. **POLITICAL CAMPAIGNS:** The FRWC is a non-political, non-partisan nonprofit organization; as such, we do not endorse candidates for political office. Political campaigns, petitioning for candidates or ballot items, or any other partisan activities are not permitted at 80's in the Hole.
6. **Vendor Responsibility:** Vendors will be fully responsible for any loss or damage to their property by theft, fire, or casualty. The Flint River Watershed Coalition and Kettering University expressly disclaim and responsibility for same. Vendors shall be responsibility for any damage which may be incurred to the facilities as a result of or in connection with its operation. Each exhibitor is responsibility for the conduct of its employees and/or representatives, and activities must not detract from the image of the event.
7. **Acceptance:** Flint River Watershed Coalition and Kettering University reserves the right to decline any application for space if it deems such action to be in the best interest of 80's in the Hole.
8. **Electrical service** is not provided. Food vendors must provide their own power. Sales vendors can request permission to bring a generator, but 80's in the Hole planning committee reserves the right to decline such requests.
9. **Tables and Chairs:** Each vendor must furnish their own tables, chairs, and popup tents. Vendors are not allowed to supply their vending space with tables and chairs from the beer tent.
10. **Cancellation of space:** Flint River Watershed Coalition and Kettering University request that vendors supply ample notice if they are unable to attend the event, so that organizers have enough time to find a replacement.

11. Indemnification: Vendor agrees to indemnify and hold harmless the Flint River Watershed Coalition and Kettering University from and against any loss, expense, claims, damages, causes of action, injuries, suites or damages, suites to person or property, including attorney's fees, arising out of or related to the operation of the Vendor at 80's in the Hole.

12. Food vendors will submit, with this contract, a copy of their Mobile Food Service license and health department certificate(s).
